# Additional time for notice of application and lodgement of statements of grounds

- 1 The Tribunal's order dated 3 September is amended by:
  - (a) Amending order 3, so that the date by which the applicant must provide the specified documents to any referral authority and objectors is changed from 8 October 2021 to 22 October 2021.
  - (b) Amending order 4, so that the date by which the applicant must provide a statement of service and specified attachments is changed from 15 October 2021 to 26 October 2021.
  - (c) Amending order 8 so that the closing date for objectors and referral authorities to provide a statement of grounds is changed from 29 October 2021 to 12 November 2021.

- The responsible authority has written to the Tribunal advising that a clerical error has meant that the full list of the persons who objected to the permit application only just been provided to the applicant.
